## CONTEST RULES

Ontario OUT of DOORS (OOD)/Esnagami Lodge Contest

1. Contest opens on February 4, 2022 at 10:00 a.m. EDT and closes on April 11, 2022.
2. The winner will receive a Trip for Two on the standard American Plan for six days and nights.
3. The winner will be picked by random draw by the Ontario OUT OF DOORS Digital Editor on April 12, 2022.
4. Approximate value of the trip is \$4,600. Prize includes round-trip float plane transfers, lodging and meals, linens, bedding, and towels, boat, motor, and gas, one day guide service, cleaning and freezing of fish, shore lunch kits, landing nets, life preservers, and boat accessories.  
***Note: Winner is responsible for their own transportation to Nakina, Ontario. The winner will be flown out to Esnagami Lodge from Nakina. Winners must comply with public health recommendations. Alcohol and fishing licences not included. OOD has no involvement of the actual trip – implementation will take place solely through Esnagami Lodge.***
5. The winner will be first contacted by email and if no response, by phone. If the winner can not be contacted or does not respond to OOD within seven days, a new winner will be drawn and the process will be repeated until a winner is reached.

7. One entry per person. Any additional entries will be void.
8. The prize must be accepted as awarded and taken on the specific dates given, to be decided within the 2022/2023 seasons and may not be transferred or exchanged.
